DEED OF VARIATION
relating to a Funding Agreement
dated 30 November 2012

THIS DEED OF VARIATION is made on 20 February 2018

BETWEEN:

- (1) The Secretary of State for Education (“**Secretary of State**”); and
- (2) Outwoods Edge Primary School, a charitable company incorporated in England and Wales with registered number 08188239 (“**Company**”)

together referred to as the “**Parties**”.

INTRODUCTION:

- (A) The Parties entered into a funding agreement dated 30th November 2012 (“**Funding Agreement**”) relating to the establishment, maintenance and funding of a school known as Outwoods Edge Primary School.
- (B) The Parties now wish to vary and amend the terms of the Funding Agreement and wish to record their agreement as to such variations/amendments to the Funding Agreement by this Deed.

IT IS AGREED as follows:

1. The Secretary of State and the Company agree that with effect from the date of this Deed the Funding Agreement shall be amended and restated in the form set out at Schedule 1 to this Deed.
2. As varied by this Deed, the Funding Agreement shall remain in full force and effect.
3. This Agreement shall be governed by and interpreted in accordance with English law.

This document has been executed and delivered as a Deed on the date stated at the beginning of this Deed.

SCHEDULE 1 - Restated form of Funding Agreement

1 Anywhere within the agreement that statements of SEN is mentioned shall be replaced with Education and Healthcare Plans.

2 Clause 17 of the Funding Agreement shall be replaced with:

17. The planned capacity of the Academy is 420 in the age range 4-11. The Academy will be an all ability inclusive school whose requirements for:

- a) The admission of pupils to the Academy are set out in Annex B to this Agreement;
- b) The admission to the Academy of and support for pupils with SEN and with disabilities (for pupils who have and who do not have Education Health and Care Plans) are set out in Annex C to this Agreement;
- c) Pupil exclusions are set out in the regulations made by virtue of section 51A of the Education Act 2002 (as may be amended from time to time, and includes any successor provisions).
